OTHER MEMBERSHIP CLASSIFICATIONS

HONORARY MEMBERSHIP

- Applications for Honorary Membership shall be submitted only by a Voting Active Fire Chief who is a member of the Association in good standing.
- Honorary Members shall not have voting rights within the Association. Honorary members are welcome to attend the monthly networking social events and fundraisers. However, they are not allowed to attend the monthly day meetings.
- Retired Active Fire Chiefs who were "Members in Good Standing" at their retirement will be granted an Honorary membership without an application.

SPECIAL MEMBERSHIP

- Applications for Special Membership shall be submitted only by a Voting Active Fire Chief, a member of the Association, is in good standing.
- Special membership can be granted to those persons who desire to be affiliated with the Bristol County Fire Chiefs' Association but do not meet any other membership classifications.
- Special Members are allowed to attend monthly meetings but cannot cast a vote. They are members who provide official support to the Association. Special Members must be excused during an executive session meeting.
- Special Members will be voted/re-voted annually by the membership.
 - Examples of Special Members include:
 - Region V EMS Director
 - MEMA District Coordinator(s)
 - State Police
 - Bristol County Control (SEMREC) Representative
 - Any other individual/agency deemed by the Active Voting Membership

- Associate members are welcome to attend the monthly networking social events and fundraisers. However, they are not allowed to attend the monthly day meetings.


ANNUAL DUES:

- **Special Member:** \$ 0.00 / annually
- **Associate Vendor** \$200.00 / annually
